Dear Friends,

"You have cancer." Few words have the power to change a life in the blink of an eye like those three small words.

When you add the surprise and fear of hearing those words to the barriers faced by many of the Northern New Mexicans we serve, you can imagine that some patients consider giving up before they begin.

When a tank of gas to get to Santa Fe, a place to spend the night, or the simple dignity of feeding one's family becomes one more seemingly insurmountable task, the resulting indecision can be paralyzing and frequently devastating.

Recently, a head and neck cancer patient faced what the rest of us can hardly imagine. Living in Guadalupita, he had no one in his family who could afford to buy gas to drive him to and from treatment. The Cancer Foundation stepped in and began providing mileage reimbursements so that his nephew would be able to drive this cherished uncle to Santa Fe to access treatment.

Your help continues to provide life-critical patient services to people like this man. For over eighteen years, the Foundation has been helping other patients in similar situations, in many instances saving lives, and all due to generous donors like you!

In the past twelve months, the Cancer Foundation supported nearly 30,000 patient visits, 900 nights of lodging, and more than 300 support group participants. With your help, we reimbursed more than 395,000 miles for treatment. The ripple effect of your support has, over the years, impacted tens of thousands of patients, family members, and friends – sometimes even entire communities.

You may never meet any of these folks or hear their names. But please know that every one of them is aware that someone out there cares for them. Most importantly, they know that they aren't in this fight for their life alone. You are there with them through the Cancer Foundation for New Mexico.

Thank you for the ways you help support our patients and our mission. We humbly ask that you continue that support by making a life-changing and life-saving contribution to our 2021 Annual Care Campaign. Every dollar given stays in New Mexico to make enormous differences for the people we serve, people like the uncle in Guadalupita and his extended family.

OUR STORY

Twenty years ago, a group of Santa Fe oncologists grew concerned that so many of their patients were unable to complete their treatments. In response, they founded the Cancer Foundation for New Mexico (CFFNM), a local, independent 501(c)(3) nonprofit organization. CFFNM provides assistance with transportation, lodging, and nutrition, as well as emotional support groups and other services, in an effort to ensure that every patient can fight their disease with dignity. With your support, we can work to offer every patient equal access to treatment and therefore, equal access to the best potential outcome.



THE YEAR IN REVIEW

Without a doubt, the last year presented significant challenges to everyone in our community. Despite the global pandemic however, CFFNM is proud to have provided uninterrupted support services to every qualifying patient and their family. Though some of our services had to adapt — support groups met online, volunteers were no longer allowed in treatment rooms, and the Supper Club and Sweetheart Auction were reinvented as virtual events — the commitment of our donors, Board of Directors, and staff ensured that patient support was unaffected.

Cancer continues to be a leading cause of death in our community. Low-income New Mexican cancer patients have always struggled disproportionately to complete their prescribed treatment; the havoc wreaked by COVID-19 has only widened this disparity. Thanks to the generous support of donors like you, low-income Northern New Mexicans living with cancer were still able to receive treatment: CFFNM supported nearly 30,000 patient visits at the Santa Fe treatment center this past year. Every donation, no matter how small, has a tangible positive impact for a cancer patient and their family.



After years of tireless service, Bud Hamilton stepped down as Chair of the Board of Directors last August. At the 7th Annual Supper Club, Bud and his wife and long-time chemo room volunteer, Valerie, were honored for their years of commitment. Executive Director, Vince Baca, presented the first ever Hamilton Visionary Award to the Hamiltons for their extraordinary service to cancer patients in New Mexico.

We're pleased to welcome Bunny Terry, former Vice-Chair and a cancer survivor herself, as our new Chair. In addition advocating fiercely for cancer patients, Bunny also runs a successful marketing and coaching business, sells property as a broker at Keller Williams Santa Fe, and recently published her first book.

In speaking about her new position as Board Chair, Bunny said, "As a Stage IV cancer survivor, helping cancer patients get to their life saving treatment is my passion. Seven years ago when Bud invited me to serve on the CFFNM board, I knew I'd finally found a place where I could serve in the most effective way. Stepping into the Board Chair role is not only an honor; it gives me a place where I can most effectively further that passion while continuing Bud's and the Board's legacy of saving lives."

Upon the passing of the gavel, Bud said, "It's been an honor and a privilege to chair the board these past 13 years. While stepping down from the board chair role, I'm not stepping away from the organization, as I will remain on the board and be very involved. I'm delighted to know the Foundation will now be in the capable hands of Bunny Terry. She has my total confidence."

MEET A PATIENT: JOCK SOTO

Jock Soto was born in Gallup, New Mexico to a Navajo Indian mother and a Puerto Rican father. Inspired by a television special featuring Edward Villella, he began studying ballet when he was five-years-old and eventually moved to New York to study at the School of American Ballet. At age 20, Jock was promoted, becoming the youngest principal dancer with the New York City Ballet. Towards the end of his career, Jock's mother passed away from cancer. When his father was diagnosed with colon cancer, Jock and his husband, Luis, moved back to New Mexico to care for him. Not long after, Jock received his own devastating cancer diagnosis.



Though Jock could no longer work, CFFNM ensured he was provided the resources to receive treatment. The Foundation provided lodging, food assistance, and emotional support, allowing Jock to receive weeks of aggressive radiation in Santa Fe and eventually beat his disease. In 2019, Jock was the featured speaker at the Supper Club, and this year, Jock joined CFFNM's Board of Directors, driven to support other cancer patients and help them receive the same assistances he so appreciated. Today, Jock continues to live in New Mexico and teaches for various prestigious dance programs.
